General Terms & Conditions

CONDITIONS OF ENTRY

- Entries open 17 August 2020
- Entries received after 30 September 2020 may not be catalogued.
- Entries close midnight 11 October 2020. There will be no late entries allowed on Equestrian Entries. However competitors can submit a written application to Kahlia via entries@hawkesbayshow.co.nz and will be charged a 25% late fee. Please check the specific closing date details regarding your chosen discipline(s).

- It is the competitor's responsibility to ensure their details of entries are correct.
- All Competitors must supervise and control their animals at all times and shall be liable for any hazards created or accident, illness or damage caused by the action of themselves or their animals at the Showgrounds.
- By entering this Show, Competitors must comply with the appropriate animal Legislation the Health & Safety at Work Act 2015 (HWSA) and any amendments thereafter.
- Entry in the Show entitles the Hawke's Bay A&P Society to publish an Competitors' name in results and distribute with Competitor Lists.
- The Society reserves the right to refuse or cancel any entry without adducing any reason for doing so.
- Competitors must check their entry carefully. A confirmation of entries will be sent, it is the competitor's responsibility to check the details are correct.
- Once entries are catalogued, changes can be made but will not be reflected in the Catalogue.
- All persons admitted into any premises controlled by the Hawke's Bay A&P Society shall be subject to the orders of the Committee and, in the event of misbehaviour on the part of anyone attending the Show such person may be removed by order of the Society. This applies to any person whose conduct, either personal or as proprietor of a side-show, or exhibit, is a source of annoyance.
- Should any person or firm be disqualified or suspended by another Association or affiliated organisation of the Royal Agricultural Society, the suspension or disqualification may also be applied by the affiliate organisations.

RAS RULES

- The RAS Judges & Competitors Rulebook (see www.ras.org.nz) sets out all the conditions that apply to the classes and sections offered. Each Breed that is affiliated to the RAS offer their own standard schedule of classes and any additional rules that apply to showing their particular breed.

SHOW LEVIES & FEES

- Grounds Levy: \$5 per animal up to 3 animals (maximum of \$15/competitor)
- Judges Levy: \$2.50 per animal excluding Goats & Poultry
- Admin Fee: \$5 per competitor (non refundable)

PRIZE MONEY

- All prize money will be paid into a nominated bank account within 30 days (subject to any queries) via Equestrian Entries. Bank accounts must be verified before payments will be made.
- Any disputes regarding prize money must be made no later than 30th November 2020
- The pay out scale is as follows:
 - If there are less than four starters in a class, only 1st place will be awarded.
 - If there are a minimum of four starters, 2nd place will be awarded also.
 - For more than five started in a class, 3rd place will be awarded to.
- Winners will be contacted by the Competition Manager via email.

CATALOGUES

- Catalogues will be available online at hawkesbayshow.co.nz or \$5 each at the main Show Office.
- If you have pre-ordered a Catalogue through the entry process, you can collect these from the Chief Steward.
- The timings in this schedule may change once final entries are received and the catalogue is produced.

ENTRY PASSES

- Wristbands are the official entry around the Showgrounds.
- Competitors will be emailed their entry confirmation closer to the Show. This confirmation will include specific details including: virtual entry pass, maps, entry gate, parking and camping areas/passes.
- Competitors will collect their 'Show Pack' including wristbands from the main Show Office on arrival at the Show. Wristbands will NOT be posted except for dog triallists.
- Wristbands are to be worn at all times for the duration of the Show.
- Additional two-day entry passes can be purchased during the entry process or at the main Show Office at the discounted rate of \$5 per person. *Replacement wristbands can be collected from the main Show Office with presentation of damaged wristband.*
- Should we return to Level 2, additional wristbands will be limited.

PARKING

- All vehicles/drivers must display the emailed entry confirmation to gain entry to the Show. Please ensure you access the allocated gate in your entry confirmation.
- For vehicles to remain in this area after hours, a 'camping' pass must be displayed.

HOUSING FOR ANIMALS

- Housing is charged at no cost but needs to be booked through the entry process.

CAMPING ON THE SHOWGROUNDS

- Non-powered sites are available at \$20 per site.
- The 'camping' pass must be displayed to have 24hr access to this area.

SCRATCHINGS

- Application for refunds must include a vet certificate or medical certificate.
- 100% refund will be paid until close of entry, 11 October 2020.
- 50% refund will be paid from 12 October 2020.
- Competitors are encouraged to do their scratching's via My Entries on Equestrian Entries AND notify the Competitions Manager, entries@hawkesbayshow.co.nz.
- Non-animal entries can be scratched on a case-by-case basis.

LATE ENTRIES & ENTRIES DURING THE SHOW

- Late entries to the Alpaca & Dog Trials sections are not permitted allowed due to biosecurity reasons.
- There will be no entries allowed on Equestrian Entries. However competitors (except Alpaca & Dog Trials sections) can submit a written application to Kahlia via entries@hawkesbayshow.co.nz and will be charged a 25% late fee.
- Please check your individual schedule details for exact dates.

STARTING TIMES

- Starting times are approximate only but the Show will endeavour to adhere to as closely as possible. When a competitor may have two classes they have entered running simultaneously then they must elect which class they compete in. Our judges and stewards will do their best to work in with everyone to the best of their ability.
- To be read in conjunction with the relevant section conditions and rules and By-Laws of the Royal Agriculture Society of New Zealand.

RIGHTS OF THE HAWKE'S BAY A&P SOCIETY

The Hawke's Bay A&P Society reserves the right to, at any time, for any reason and without notice to:

- Refuse or cancel any entry
- Alter the Show timetable
- Withdraw or change any event or class
- Combine classes where there are insufficient entries
- Remove any dangerous or inappropriate exhibit or display

YELLOW CARD SYSTEM

- This Show supports the RAS "Yellow Card" system which will operate in all sections and will be used for any inappropriate behaviour towards show officials, judges, fellow competitors or any other third party connected with the show.
- The full working of the "Yellow Card" system is available to view on the RAS website.

BIOSECURITY

- The Hawke's Bay A&P Society supports all appropriate biosecurity regulations. Please check your individual sections for guidelines.

PROTESTS

- All protests must be in writing and may be lodged with the Section Chief Steward/ Section Head one hour from the completion of the class judged, together with a deposit of \$50 which shall be returned should the protest be upheld. No protest will be received later than one hour after the ribbons are affixed.

HEALTH & SAFETY

- Competitors must comply with the appropriate animal legislation and the Health and Safety at Work Act 2015 and any amendments thereafter.
- The Association will not be responsible for any accident, loss or damage that may be caused directly or indirectly to or suffered by an exhibit.
- Each competitor must supervise and control their animals at all times and shall be liable for any hazards created or accidents, illness or damage caused by the action of themselves or their animals at the showgrounds. The Society reserves the right to order immediate removal from the Showgrounds any animals deemed unruly or dangerous.
- Persons occupying grandstands, buildings and other structures or other seating accommodation on the Showgrounds do so at their own risk.
- The full Health & Safety Policy & Management Plan is available at the Show Office and is available on the Show website and with the Chief Steward/Head of Section.

PRIVACY

- Entry into the Show entitles the Hawke's Bay A&P Society to publish a competitors' name in the results and distribute with competitor lists.

DOGS

- All non-competing dogs are banned from the Hawke's Bay Showgrounds.

TROPHIES & CUPS **this is an introduced policy in 2020.*

- All recipients of Hawke's Bay A&P Society trophies, cups and other perpetual prizes are required to take prize upon winning however to remove the prize from the Showgrounds, the recipient must sign for the prize and provide contact details.
- All trophies must be returned clean, engraved and in good condition to the Section Head or the Show Office by 1 August the following year. The prize will then be signed back into the care of the Hawke's Bay A&P Society.

PREPARATION FOR DEPARTURE

- Clean out all animal housing to the standard of your Section Head.
- Notify your Section Head of any damage or repairs and maintenance required.
- Remove all rubbish and personal belongings.
- Check with the Section Head prior to departure that your animal housing is satisfactory.
- Check your individual schedules for any specific details related to the section.
- Pay all outstanding fees before departing the Showgrounds.
